CRAAR Late Fee Policy

Section 4. Nonpayment of Financial Obligations. If dues, fees, fines, or other assessments including amounts owed to the Board or the Board's Multiple Listing Service are not paid by the due date, a \$25 late fee will be assessed. After being assessed a \$25 late fee, those members who have not paid their statement in full will be charged a \$100 late fee on the following month's statement. Any member that has been assessed a \$100 late fee is at risk of membership termination. To avoid such termination, that member shall pay their account in full with certified funds or credit card prior to the BOD meeting for the month in which the \$100 was assessed.

Members subject to termination for nonpayment will be notified of the Board of Directors meeting date a minimum of 3 business days in advance of their potential termination. However, no action shall be taken to suspend or expel a Member for nonpayment of disputed amounts until the accuracy of the amount owed has been confirmed by the Board of Directors. A former Member who has had his membership terminated

for nonpayment of dues, fees, fines, or other assessments duly levied in accordance with the provisions of these Bylaws or the provisions of other Rules and Regulations of the Board or any of its services, departments, divisions or subsidiaries may apply for reinstatement in a manner prescribed for new applicants for membership, after making payment in full of all accounts due as of the date of termination.

All MLS Participants must offer or accept cooperation to and from other participants (or be licensed or certified by a state regulatory agency to engage in the appraisal of real property). Participants actively—continually and on an ongoing basis—endeavor to a. list real property of the type listed on the MLS in which participation is sought and/or b. accept offers of cooperation made by listing brokers in the MLS.
